





1 Short title

This Act is the Divisional Amendment (New Eurabba) Act 2023.

2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

Omit "Treaty on Corporation and Establishment of the Ecological County (Sanctuary) of Urabba", substitute "Treaty on Corporation and Establishment of the Ecological County (Sanctuary) of New Eurabba".

Omit "Urabba Street Reserve as".

Omit "willing to establish a jurisdictional division for Urabba Street Reserve known as the Flandrensian Ecological County of Urabba", substitute "considers it desirable to establish a region of Urabba Parks known as the Flandrensian Ecological County of New Eurabba".

Omit "for the government of a jurisdictional division where the legislature of the jurisdictional division does not have power to legislate", substitute "to admit and establish new regions".

3 Section 1

Omit "Flandrensian Ecological County of Urabba Act 2022", substitute "Flandrensian Ecological County of New Eurabba Act 2023".

Note: This item amends the short title of the Act. If another amendment of the Act is described by reference to the Act's previous short title, that other amendment has effect after the commencement of this item as an amendment of the Act under its amended short title (see section 10 of the *Interpretation Act 2022*).

4 Section 3 (definition of County)

Repeal the following definitions:

- (a) definition of *County*;
- (b) definition of Manager.

5 The whole of the Act

Manager means the Manager of New Eurabba for the time being or some other person exercising the power of the Manager.

New Eurabba means the Flandrensian Ecological County of New Eurabba.

8 Section 4

Omit "Urabba", substitute "New Eurabba".

10 Subsection 5(1)

Repeal the subsection, substitute:

 There shall be a region of Urabba Parks having the territory of Ward B of Carrathool Shire in New South Wales (as existing at the commencement of the *Divisional Amendment (New Eurabba) Act* 2023) under the name Flandrensian Ecological County of New Eurabba.

11 Subsection 5(2)

Repeal the subsection, substitute:

(2) The Parliament, with the consent of the Grand Duchy of Flandrensis, declares all parts of Urabba Parks within New Eurabba as an ecological sanctuary under article 1.4 of the Constitution of the Grand Duchy of Flandrensis.

12 After subsection 5(2)

Insert:

- (3) No person has the right to occupy any land declared under subsection (2) on the basis of any interest in the membership of Urabba Parks.
- (4) The legislative power of New Eurabba is vested in the Enactor.
- (5) The Enactor may only exercise the legislative power in subsection (4) to enact the referral statute.

The Enactor of Urabba Parks in Right of the Flandrensian Ecological County of New Eurabba enacts:

1 Short title

This Act is the Referral Act 2023.

Evidence of the date of assent of the referral statute shall be provided in the same manner as an Act.

Note: Section 20 of the *Interpretation Act 2022* provides for the date appearing on the copy of an Act printed by the Government Printer as evidence of date of assent.

21 Numbering of referral statute

The referral statute shall be numbered in the same manner as an Act.

Note: Section 77 of the *Interpretation Act 2022* provides for the numbering of Acts in the order of assent in a particular year.

22 Registration of referral statute

The Company Secretary must register the referral statute under the *Legislation Act 2022* as soon as practicable after it is assented to.

Treaty Amending the Treaty of Corporation and Establishment of the Ecological County (Sanctuary) of Urabba



BETWEEN the Grand Duchy of Flandrensis (Groothertogdom Flandrensis) and Urabba Parks Proprietary Limited Hereinafter referred to as "parties"

Signed on the **4th** day of the month of **September** in the Gregorian Year of **2023** under the joint consent of both parties.

1. Name

This Treaty is the Treaty Amending the Treaty of Corporation and Establishment of the Ecological County (Sanctuary) of Urabba.

2. Commencement

This Treaty comes into effect on a day appointed by Urabba Parks Proprietary Limited.

3. Amendments

Provisions of the Treaty of Corporation and Establishment of the Ecological County (Sanctuary) of Urabba originally entered into by the parties on 18 August 2022 is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this Treaty has effect according to its terms.

Schedule 1—Amendments to the Treaty of Corporation and Establishment of the Ecological County (Sanctuary) of Urabba

1. Title

Omit "Urabba", substitute "New Eurabba".

2. Article 3 (definition of *County*)

Omit "Urabba", substitute "New Eurabba".

3. Article 3 (definition of Urabba Street Reserve)

Repeal the definition.

4. Subarticle 5.1

Omit "There shall be a territory", substitute "The New Eurabba region".

Omit "having the area of Urabba Street Reserve with the name Flandrensian Ecological County of Urabba", substitute "shall be established as the Flandrensian Ecological County of New Urabba".

5. Subarticle 5.3

Omit "Urabba Street Reserve", substitute "land it principally occupies in the County".

Omit "the area of the County", substitute "an ecological sanctuary of the Grand Duchy of Flandrensis".

6. Subarticle 5.4

Omit "person", substitute "member of Urabba Parks Proprietary Limited". Omit "abode", substitute "occupancy".

7. Subarticle 6.1

Omit "may only legislate for the County in the circumstances specified in Schedule 1", substitute "shall consult with the Grand Duchy of Flandrensis on any legislative proposal that affects the County".

8. Subarticle 6.2

Omit "may only change its Constitution if required under an Australian law or court/tribunal order, or if the change is reasonable having regard to its obligations under this Treaty", substitute "shall have regard to its obligations under this Treaty in assessing the reasonableness of an amendment to its Constitution or any act having similar status".

9. After subarticle 6.2

Insert "3. No law or act is invalid merely by failure to consult or consider under this clause.".

10. Article 8

Repeal the article, substitute:

8. Exiting the arrangement

This Treaty shall be revoked if:

(a) there ceases to be any area subject to the laws of the County;

(b) if either party is dissolved or enters external administration; or

(c) 30 days after a party sends a show cause notice under this subarticle to the other party, unless the notice is withdrawn;

and upon revocation of this Treaty the parties shall stop recognising the area forming the County as an ecological sanctuary of the Grand Duchy of Flandrensis and Urabba Parks Proprietary Limited shall stop using the identity of the Grand Duchy of Flandrensis in relation to any of its activities, unless otherwise authorised by the Grand Duchy of Flandrensis.

11. Article 9

Omit "the party", substitute "a party".

Omit "declared as such for the purposes of this article", substitute "produced, used or transferred under this Treaty".

Omit "parties involved in the production of the material", substitute "party".

12. Article 10

After "enterprise", insert "between the parties".

13. Schedule I

Repeal the schedule.



Attachment 2—Explanatory Statement

On 11 August 2023, at an unpaid rates auction held on behalf of Carrathool Shire Council by Griffith Real Estate at the Griffith Leagues Club (Southside), the Enactor signed a contract to purchase of land located at Lot 8, Section 3 of Deposited Plan 759145 being located at King Street Gunbar, for upfront payment of \$6,500. It has been confirmed by way of an emailed Settlement Notification from Property Exchange Australia that settlement has occurred. All costs of the acquisition have been paid by Mister Enactor personally. The Enactor intends to take up equity in Urabba Parks in consideration for the payment of costs, and to name the property "Promachos" in honour of honour of those who fought for Australia, in particular John William Alexander Jackson, recipient of the Victoria Cross, who was born at "Glengower", Gunbar, on 13 September 1897 and died 4 August 1959 at the Austin Hospital, Heidelberg, Melbourne. Currently there is no statutory basis for naming of locations within Urabba Parks, and this involves an exercise of Enactorial Prerogative under Letters Patent. Promachos sits within Ward B of Carrathool Shire, which has been declared the territory of the New Eurabba region by the Divisional Amendment (New Eurabba) Act 2023, given Enactorial Assent on 4 September. This Minute recommends the contract be ratified and the site be named as proposed.

Explanatory Memorandum – Minute No. 1 of 2023

Subject

Constitution

Treaty Amending the Treaty of Corporation and Establishment of the Ecological County (Sanctuary) of Urabba

Urabba Parks' treaty-making power is exercisable by the Manager-General by virtue of Chapter II of the Constitution which provides, among other things, that the executive power of Urabba Parks is vested in the Enactor and is exercisable by the Manager-General. The treaty-making power includes the power to conclude treaties with micronations, which are self-declared states. Urabba Parks does not regard micronations as states and therefore treats such entities as nonstate jurisdictions. The Minute recommends that Urabba Parks sign a bilateral treaty with the Grand Duchy of Flandrensis entitled the "Treaty on Corporation and Establishment of the Ecological County (Sanctuary) of Urabba" (the *amending Treaty*).

The amending Treaty is to be signed 4 September by Nicholas de Mersch d'Oyenberghe (Niels Vermeersch), Grand Duke. This is on the first anniversary of the coming into force of the original Treaty on Corporation and Establishment of the Ecological County (Sanctuary) of Urabba (the *principal Treaty*), which was signed on 18 August 2022 and came into force on 4 September 2022. The fourth day of September is marked as Flandrensis Day, and the date of signing of the amending Treaty will be on the 15th anniversary of the creation of Flandrensis.

The principal Treaty provides that Urabba Parks is to establish a territory and declare it an ecological sanctuary under the Constitution of the Grand Duchy of Flandrensis under the name Flandrensian Ecological County of Urabba. The main purpose of the Treaty is to amend the principal treaty to effect the change of name of the Urabba territory to New Eurabba, provide the jurisdictional division is a region of Urabba Parks, and change the name of the principal Treaty to the Treaty on Corporation and Establishment of the Ecological County (Sanctuary) of New Eurabba. The new name will enable discoverability under the name "Eurabba", the origin of the name "Urabba". The designation of New Eurabba as a

region will protect its historical significance as the homeland of Urabba Parks.

Notes on the articles of the amending Treaty are attached. The Minute recommends that approval be given in the form proposed.

Notes on articles

1. Name

1. This article provides that the name of the amending Treaty is the Treaty Amending the Treaty of Corporation and Establishment of the Ecological County (Sanctuary) of Urabba.

2. Commencement

2. This article provides for the amending Treaty to commence on a day appointed by Urabba Parks, and is expected to be when the law establishing the Urabba territory as the New Eurabba region.

3. Definitions

3. This article gives effect to the amendments in the Schedule.

Schedule 1—Amendments to the Treaty of Corporation and Establishment of the Ecological County (Sanctuary) of Urabba

4. Items 1 and 2 substitute Urabba" for "New Eurabba" in the Title in article 1 and definition of *County* in article 3.

5. Item 3 repeals the definition of *Urabba Street Reserve* in article 3. Currently, the Urabba territory is limited to the area of Urabba Street Reserve only. Under the principal Treaty as amended, the territorial extent of New Eurabba as a region will be determined by Urabba Parks, whereas.

6. Item 4, in subarticle 5.1, effects the name, designation and territorial change by:

(*A*) substituting "There shall be a territory" for "The New Eurabba region"; and

(B) substituting "having the area of Urabba Street Reserve with the name Flandrensian Ecological County of Urabba", for "shall be established as The Flandrensian Ecological County of New Eurabba", removing references to the territorial extent of the New Eurabba region.

7. Item 5 in subarticle 5.3 amends the provisions declaring the jurisdictional division as an ecological sanctuary of Flandrensis:

(A) substitutes "Urabba Street Reserve" for "land it principally occupies in the County"; and

(B) substitutes "the area of the County" for "an ecological sanctuary of the Grand Duchy of Flandrensis".

8. Item 6 in subarticle 5.4 clarifies the charitable use policy:

(A) substitutes "person" for "member of Urabba Parks Proprietary Limited".

(B) substitutes "abode" for "occupancy"

9. Item 7 substitutes "may only legislate for the County in the circumstances specified in Schedule 1" for "shall consult with the Grand Duchy of Flandrensis on any legislative proposal that affects the County" in subarticle 6.1. This frees the governance arrangements of unnecessary provisions, as it will be unlikely Flandrensis would ever make use of the disallowance provisions.

10. Item 8 substitutes "may only change its Constitution if required under an Australian law or court/tribunal order, or if the change is reasonable having regard to its obligations under this Treaty", for "shall have regard to its obligations under this Treaty in assessing the reasonableness of an amendment to its Constitution or any act having similar status" in subarticle 6.2. This replaces unnecessary provisions with more appropriate expectations owing to the informal nature of the relationship between Urabba Parks and Flandrensis.

11. Item 9 inserts a new subarticle after subarticle 6.2 "3. No law or act is invalid merely by failure to consult or consider under this article." This clarifies the principles outlined in notes 9 and 10.

12. Item 10 removes and substitutes article 8:

8. Exiting the arrangement

This Treaty shall be revoked if:

(c) 30 days after a party sends a show cause notice under this subarticle to the other party, unless the notice is withdrawn;

and upon revocation of this Treaty the parties shall stop recognising the area forming the County as an ecological sanctuary of the Grand Duchy of Flandrensis and Urabba Parks Proprietary Limited shall stop using the identity of the Grand Duchy of Flandrensis in relation to any of its activities, unless otherwise authorised by the Grand Duchy of Flandrensis.

13. Item 11, in article 9:

(A) substitutes "the party" for "a party"; and

(*B*) substitutes "declared as such for the purposes of this article", substitutes "produced, used or transferred under this Treaty"; and

(C) substitutes "parties involved in the production of the material", substitutes "party".

14. Item 12 inserts "between the parties" after "enterprise" in article 10.

15. Item 13 repeals Schedule I of the principal Treaty.

INTRODUCTORY SPEECHES

Divisional Amendment (New Eurabba) Bill 2023

This Bill brings into force for Urabba Parks the amendments to the Treaty of Corporation and Establishment of the Ecological County (Sanctuary) of New Eurabba (formerly the Treaty of Corporation and Establishment of the Ecological County (Sanctuary) of Urabba), the amendments which were agreed to by Urabba Parks and the Grand Duchy of Flandrensis 4 September 2023.

Furthermore, the Bill establishes the Urabba territory as the New Eurabba region, gives the jurisdictional division the area of Ward B of Carrathool Shire Council and puts in place a New Eurabban law referring all legislative matters to the Corporate Parliament. This will avoid the need for the creation of a separate regional administrative structure, while providing for the establishment of New Eurabba as the home region of Urabba Parks, which will encompass the existing Urabba Street Reserve site and a new site at Gunbar which was purchased on 11 August 2023 and is due for settlement this week.

Membership (Promachos) Bill 2023

This Bill will grant Park Ranger's Membership in respect of the acquisition of a new site at Gunbar which has been called 'Promachos' in honour of William Jackson VC. Promachos will fall in the jurisdiction of the New Eurabba region and within the internal municipal district the Campus of Rankins Springs, which like the New Eurabba region has the area of Ward B of Carrathool Shire. This Bill provides for the allotment of 50 shares of ordinary membership in the Park Ranger's class fully paid to a total of \$7,611, representing the purchase price and finalised costs of acquisition.

With \$7,611 already granted by the enactment of the previous Bill, this Bill once enacted will bring the total membership granted to a value of \$7,776.

Outline

The Bills to which this Explanatory Memorandum relate will implement in Urabba Parks the amendment to the renamed Treaty on Corporation and Establishment of the Ecological County (Sanctuary) of New Eurabba (formerly the Treaty on Corporation and Establishment of the Ecological County (Sanctuary) of Urabba) (the *Treaty*) with the Grand Duchy of Flandrensis, which Urabba Parks had originally signed on 18 August 2022 and amended on the first anniversary of its operation, on 4 September 2023. The Treaty has been amended to rename the Urabba territory as New Eurabba and designate it a region with territory defined by Urabba Parks and simplify governance procedures. The membership Bills to which this Explanatory Memorandum relate will grant membership in the Promachos site at Gunbar, which will form part of the newly renamed New Eurabba region.

New Eurabba became Urabba Parks' first jurisdictional division and territory under the name Flandrensian Ecological County of Urabba, on the commencement of the *Flandrensian Ecological County of Urabba Act 2022*, 4 September 2022, being the anniversary of the creation of the Grand Duchy of Flandrensis. New Eurabba will now be a region rather than a territory, being a full federated jurisdiction of Urabba Parks. However, the legislature of New Eurabba will refer all its power to the Corporate Parliament, avoiding the need for a creation of a separate New Eurabban legislative structure. Executive and judicial functions will continue to be provided by Urabba Parks. There will also be consent in the New Eurabban law for the consent to surrender territory as determined by the Corporate Parliament, allowing for creation of a Seat of Government at Urabba Street Reserve.

Constitutional Provisions

The principal method of creating regional laws for New Eurabba will remain by way of an Ordinance, which can be made by the Manager-General in Council, or (subject to delegation) by the Manager of the region with the approval of the responsible Minister. This Bill provides that Ordinances are subject to disallowance by the Corporate Parliament, in addition to being disallowable under the *Legislation Act* 2022. The Bill removes the opportunity for disallowance of Ordinances by Flandrensis under the terms of the revised Treaty.

STATEMENT OF REASONABLENESS

Divisional Amendment (New Eurabba) Bill 2023 (the *Divisional Amendment Bill*)

Membership (Promachos) Bill 2023 Membership (Athena Urabbanakis Society) Bill 2023 (the *Membership Bills*)

Together called the Blackstump Bills

The Blackstump Bills are reasonable having regard to the legal and ethical obligations of Urabba Parks.

Overview of the Bills

S1. The Blackstump Bills consist of a Divisional Amendment Bill and Membership Bills. The Divisional Amendment Bill is intended to reform the Flandrensian Ecological County of Urabba, a territory of Urabba Parks, as a region of Urabba Parks under the name Flandrensian Ecological County of New Eurabba with an area having the size of Carrathool Shire Ward B. The Membership Bills grant membership in relation to a new Urabbaparcensian site at Gunbar, known as Promachos, which will form part of what is to be the New Eurabba region.

Power to enact Bill

S2. Section 121 of the Constitution confers Parliament the power to enact laws "to admit to Urabba Parks or establish new regions, and may upon such admission or establishment make or impose such terms and conditions, including the extent of representation in a House of the Parliament, as it thinks fit." This allows the Parliament to admit New Eurabba as a region.

S3. Paragraph 51(xvi) of the Constitution confers Parliament the power to enact laws relating to securities, and as membership is in the form of shares, a form of security, extends to the original grant of membership, being an allotment of shares. Under section 55 of the Constitution, Membership Structure Bills (including an original grant of membership) cannot be combined with other Bills, therefore the

Membership Bills must be passed separately from the Divisional Amendment Bill.

Promotion of rights under the Urabba Parks Bill of Rights

S4. Urabba Parks has regard respect in its governance, management and operations human rights within the meaning of section 134 of the Constitution. That constitutional provision defines human rights as being those recognised under section 3 of the *Human Rights (Parliamentary Scrutiny) Act 2011* of the Commonwealth (the 'nationally-recognised human rights'). Although the Divisional Amendment Bill affects the governance of the New Eurabba region, no person will be disenfranchised as a result, as there are no New Eurabban electors who are entitled to vote on such change. The Membership Bills only touch matters relating to the financing of the acquisition of a new site. All relevant Bills are effectively of an administrative nature only and do not materially affect human rights.

Responsibilities under intermicronational treaties

S5. The Bills touch matters within the purview of the Treaty on Corporation and Establishment of the Ecological County (Sanctuary) of New Eurabba with the Grand Duchy of Flandrensis, as amended 4 September 2023. All the proposals related to the Bills are compatible with the Treaty as amended and have been agreed to in principle by Grand Duke Nicholas of Flandrensis.

Financial impact

S6. There is not expected to be any material financial consequences from the Divisional Amendment Bill. Administrative costs in relation to the preparation of the Blackstump Bills and associated documents have been borne by Mister Enactor from his personal funds and are minimal. There are no signs inscribed with the existing full name of New Eurabba, the Flandrensian Ecological County of New Eurabba.

S7. The Membership Bills are also not expected to affect cash flows, as the membership granted is for non-cash consideration of debt owed to Mister Enactor in his own personal capacity in respect of the Promachos acquisition. As a result of the equity issue, the net asset position will

increase by the total amount taken to be paid on the membership issued, which will present favourably in the balance sheet.

Conclusion

The Bills to which this Explanatory Memorandum relate are reasonable, having regard to the legal and ethical obligations of Urabba Parks.

Clause 1: Short title

1. This clause is a formal provision and specifies that the short title of the Act resulting from the enactment of this Bill is the *Divisional Amendment (New Eurabba) Act 2023*.

Clause 2: Commencement

2. This clause provides for the commencement of the Bill as an Act immediately after the Enactorial Assent.

Clause 3: Schedules

3. This clause gives effect to the Schedules to the Bill which amend the law establishing the Urabba territory to designate it as a region.

Schedule 1—Admission of New Eurabba as a region

4. Schedule 1 has 2 parts, one dealing with amendments and another with the proof of assent and registration of the New Eurabban 'referral statute' enacted by the Enactor in Right of the region, referring all regional legislative power to the Corporate Parliament and consent to the surrender of territory.

Part 1—Amendments

5. Part 1 of Schedule 1 amends the *Flandrensian Ecological County of Urabba Act 2022* to:

(A) rename Urabba as New Eurabba and update references to the Treaty – items 1, 2, 6, 7, 8, 9 and 11;

(B) rename the principal law as *Flandrensian Ecological County of New Eurabba Act 2023* – item 3;

(C) replace standalone references to the word 'County' with New Eurabba – items 4 and 5;

(D) admit New Eurabba as a region with territory of the region to include Carrathool Shire Ward B – item 10;

(E) implement revised governance arrangements – items 3, 12, 13, 14 15, 16, 17 and 18.

6. Item 18 inserts a section and a schedule at the end of the Act which contains the referral statute – the law to be enacted by Mister Enactor in Right of New Eurabba. The referral statute will be the only New Eurabban principal legislation and will refer all regional legislative power to the Corporate Parliament.

Schedule 1 (of the amended principal Act)-Referral statute

Section 1: Short title

7. This section gives the referral statute the short title of *Referral Act* 2023.

Section 2: Commencement

8. This section provides for commencement of the referral statute upon Enactorial Assent.

Section 3: Referral of power and consent to surrender territory

9. This section refers all legislative power in and for New Eurabba to the Parliament of Urabba Parks and consents to the surrender of any territory of New Eurabba to Urabba Parks as determined by the Parliament of Urabba Parks.

Part 2—Matters relating to the referral statute

10. This Part deals with matters relating to the referral statute, which refers all divisional legislative power of New Eurabba to the Corporate Parliament and consents to the surrender of territory. Item 19 defines the referral statute as the law contained within item 18.

11. Item 20 provides that evidence for assent of the referral statue is that of an Act. Section 20 of the *Interpretation Act 2022* provides for the date appearing on the copy of an Act printed by the Government Printer as evidence of date of assent.

12. Item 21 provides the referral statute shall be numbered in the same manner as an Act. Section 77 of the *Interpretation Act 2022* provides for the numbering of Acts in the order of assent in a particular year.
